The Transportation Disadvantaged Coordinating Board (TDCB) was established by the Hillsborough County Metropolitan Planning Organization and charged with oversight and advisory responsibilities for the local transportation disadvantaged system. This system provides transportation to persons who do not have the means or ability to transport themselves, and generally includes persons who are elderly, disabled or economically disadvantaged.
